



RENAULT NOVEMBER SUBSCRIPTION PROMOTIONS

TERMS & CONDITIONS

SECTION A. General Terms and Conditions

1. The "Renault November Subscription Promotions" ("**Campaign**") is organized by TC Euro Cars Sdn. Bhd. (Company No. 198401001084) ("**TCEC**").
2. This Campaign shall be valid from **1st November 2023** until **30th November 2023** (both dates inclusive) ("**Campaign Period**").
3. TCEC reserves its absolute right to vary (whether by addition, deletion or modification) ("**Amendments**") the Campaign's terms and conditions ("**T&C**") without assigning any reasons thereof. Notification of such Amendments will be posted at the TCEC's website (www.renault.com.my) and the Amendments shall be effective and deemed binding on the date of notification of the Amendments or from such other date as may be specified by TCEC in the notification. You are advised to check these T&C regularly to ensure that you are aware of all the latest terms governing the Campaign.
4. By participating in this Campaign, you are deemed to have read, understood and agreed to be bound by the T&C stated herein including any Amendments that may be made from time to time.
